## 30. INSTALLATION RATES

### HOW DO TRAVEL AND PER DIEM CHARGES IMPACT THE HOURLY RATE FOR FURNITURE INSTALLATION?

Travel and per diem are covered by the rules set forth in the Federal Travel Regulations, and/or Joint Travel Regulations, pursuant to Clause C-FSS-370, and are not technically managed by the GSA Schedule contract. As such, in accordance with GSA's dependence on the Federal Travel Regulations, and/or Joint Travel Regulations, travel and per diem expenses are not included in the contracted hourly rate for installation services listed within the Watson Furniture Group schedule.

Travel and per diem required in the performance of installation work covered by this schedule, and provided by Watson Furniture Group or its affiliates, must comply with the Federal Travel Regulations, as applicable and in effect on the date(s) the travel and work is performed. Established Federal Government per diem rates will apply to all contractor travel. Contractors cannot use GSA city pair contracts. The contractor shall not add the Industrial Funding Fee onto travel costs.

NOTE: In accordance to the Federal Travel Regulations and GSA rules outlined above, you may see that your Watson Consoles (Watson Furniture Group) order shows:

- 1) An hourly installation rate higher than the hourly rate as it appears on the GSA contract; this will include the hourly work rate, plus travel and per diem, OR
- 2) A second line-item charge for Installation Travel, which will include travel and per diem.

You may request that Watson Furniture Group provide a separate line item showing Installation and Travel costs.
